Dear Shareholder(s),

- Sub: Communication on Tax Deduction at Source (TDS) for Final Dividend: Relevant documents for Tax exemption including Form 15G/15H to be submitted online on or before Monday, August 4, 2025 by 4:00 P.M.
- We are pleased to inform you that the Board of Directors at its Meeting held on Tuesday, April 29, 2025 has recommended final dividend of 50% i.e. Rs. 5/- (Rupees Five only) per equity share of face value of Rs.10/- (Rupees Ten) for the financial year 2024-25, subject to approval of the shareholders at the ensuing Annual General Meeting (AGM) of the Company to be held in the month of August 2025.
- 2. The final dividend of Rs. 5/- (Rupees Five only) will be paid to those shareholders who hold equity shares of the Company as on the closure of Record Date i.e. **Thursday, July 31, 2025**.
- 3. As per the Income Tax Act, 1961 ('the Act'), as amended by the Finance Act, 2020, dividends paid or distributed by the Company on or after April 1, 2020, are taxable in the hands of the shareholders. Therefore, the Company is required to deduct TDS at the prescribed rates applicable to each category of shareholders at the time of making the said payment of dividend.
- 4. Also note that for seeking exemptions, the relevant documents including Form 15G/15H are to be submitted online on or before **Monday**, **August 4**, **2025 by 4:00 P.M.** Link for submission of the documents is brought out in para no. 11. Any documents submitted after the specified date will not be accepted.

All shareholders are requested to ensure that the below information and details are completed and/or updated, as applicable, in their respective demat account(s) maintained with the Depository Participant(s); or in case of shares held in physical form, with Data Software Research Company Pvt. Ltd, Company's Registrar and Transfer Agent ("RTA"), on or before the Record Date i.e. Thursday, July 31, 2025. Please quote all the folio numbers under which you hold your shares while updating the records.
- 6. Please note that the following information & details, if already registered with the RTA and Depositories, as the case may be, will be relied upon by the Company, for the purpose of complying with the applicable TDS provisions:

- 7. All shareholders are requested to register/ update their complete bank details:

 - ii. with the Company / RTA by emailing at <u>ssc@bharatpetroleum.in</u> or <u>bpcl@dsrc-cid.in</u> if shares are held in physical mode, by submitting:
 - scanned copy of the signed request letter which shall contain Member's name, folio number, bank details (Bank account number, Bank and Branch Name and address, IFSC, MICR details),
 - self-attested copy of the PAN card, and
 - cancelled cheque leaf
 - iii. Pursuant to SEBI circulars, with effect from April 01, 2024 shareholders (including shareholders holding shares in physical form) shall be paid dividend only through electronic mode. Such payment shall be made only after furnishing the PAN, choice of nomination, contact details including mobile number, bank account details and specimen signature by such shareholders.

The Certificate should be valid and should cover dividend income. Or Valid self-attested documentary evidence (e.g. relevant copy of registration, notification, order, etc. by Indian tax authorities) in support of the entity being entitled to exemption from TDS is to be submitted.

- Other documents under sections 196, 197A, FPI Registration Certificate, Tax Residency Certificate, Lower Tax certificate, Rule 37BA declaration etc. can be uploaded on the link <u>http://182.76.145.116:280/Pages/MainPage.aspx</u> on or before Monday, August 4, 2025 by 4:00
 P.M. to enable the Company to determine the appropriate TDS applicable. Any communication on the tax determination/deduction received after Monday, August 4, 2025 shall not be considered.
- iii. Alternatively in line with the NSDL Circular No: NSDL/CIR/II/03/2023 dated 11.01.2023, the Resident Non-Individual Members such as Insurance companies, Mutual Funds, Alternative Investment Fund (AIF) and other domestic financial institutions established in India and Non-Resident Non-Individual Members such as Foreign Portfolio Investors may also submit the relevant forms, declarations and documents through their respective custodians who are registered with NSDL for tax services, on or before the Record Date i.e. Thursday, July 31, 2025.
- 12. Shareholders are requested to submit new 15G/15H form for every dividend declared by the Company. In case where new forms are not received, the benefit for such cases shall be denied in that round of dividend and cumulative amount of dividend shall be considered for computation of TDS.
- 13. All the above referred tax rates will be enhanced by surcharge and cess, wherever applicable.
- 14. <u>Timeline for deduction of TDS:</u>
 - i. In case of Residents, as per the provisions of section 194, TDS is required to be deducted at the time of payment.
 - ii. In case of Non-residents, as per the provisions of section 195, TDS is required to be deducted at the time of credit or payment whichever is earlier. Therefore, in line with the provisions of section 195 TDS is required to be deducted at the time of declaration in case of interim dividend and in case of final dividend at the time of its declaration on the date of AGM being the date it is credited to the books of account.
- 15. Application of TDS rate is subject to necessary verification by the Company of the shareholder details as available in Register of Members as on the record date, and other documents available with the Company/ RTA.
- 16. For all self-attested documents, shareholders must mention on the document "certified true copy of the original". For all documents being submitted by the shareholder, the shareholder undertakes to produce the original document(s) for verification on the request by the Company.
- 17. In case, the dividend income is assessable to tax in the hands of a person other than the registered shareholder as on the record date, the registered shareholder is required to furnish a signed declaration (Format attached as Annexure 2) containing the name, address, PAN of the person to whom TDS credit is to be given and reasons for giving credit to such person on or before Monday, August 4, 2025 by 4:00 P.M. No request in this regard shall be accepted by the Company/RTA after the said date.

- 18. We shall arrange to email the soft copy of TDS certificate at your registered email ID in due course, post payment of the dividend and filing of TDS return. Shareholders will be able to download Form 26AS from the Income Tax Department's website https://www.incometax.gov.in
- 19. It may be further noted that in case the tax on dividend is deducted at a higher rate in case of non/ delayed receipt of the aforementioned details/documents, there would still be an option available with the shareholder to file the return of income and claim an appropriate refund, if eligible. No claim shall lie against the Company for such taxes deducted.
- 20. In the event of any income tax demand (including interest, penalty, etc.) arising on BPCL on account of any misrepresentation, inaccuracy or omission of information provided / to be provided by the shareholder(s), such shareholder(s) will be responsible to indemnify the Company and also, provide the Company with all information / documents and co-operation in any appellate proceedings.
- 21. Incomplete and/or unsigned forms, declarations and documents will not be considered by the Company for granting any exemption.
