



## MEDICAL OFFICERS ON CONTRACT BASIS

**BPCL Kochi Refinery, Ambalamugal, Kochi, Kerala**

Bharat Petroleum Corporation Ltd. Kochi Refinery invites application from eligible candidates for 'Medical Officers on contract basis at Kochi Refinery, Ambalamugal, Kochi.

### TERMS AND CONDITIONS

1. The candidate shall:

- i) possess MBBS degree from a University recognized by the Medical Council of India (self attested copy of the MBBS degree certificate shall be submitted).
- ii) have completed house surgery and should have registered with the Travancore Cochin Medical council, Trivandrum (self attested copy shall be submitted).
- iii) Candidate who have AFIH (Associate Fellow of Industrial Health) shall be given additional weightage.
- iv) not have completed 58 years as on 1<sup>st</sup> July, 2023.
- v) possess Aadhaar card, PAN card and savings Bank account.

2. The Medical officer who would be engaged on contract basis will be included in the Kochi Refineries panel of Medical Officers and would be engaged as per requirement and shall:

- i) attend shift duty at the Occupational Health Centre ( OHC ) of BPCL Kochi Refinery, Ambalamugal as per the shift schedule assigned which may include Saturdays, Sundays, Holidays and Hartal days.
- ii) be available at the OHC during the scheduled shift duty timings, as per the shift schedule assigned and shall attend the D(Day) shift, E(Evening) shift, N(Night) shift as well as G(General) shift duty as per the requirement of the OHC. **Day shift – 0700 hrs to 1500 hrs, Evening shift – 1500 hrs to 2300 hrs, Night shift – 2300 hrs to 0700 hrs, General shift – 0815 hrs to 1700 hrs.**

iii) reside within 25 kms. from Ambalamugal.

3. Since the OHC is functioning on all the days of a year, the services of the Medical officer should be available at the OHC on all the days of the year, depending upon the shift schedule, and also to meet the emergency requirements.
4. The Medical officers can have Breakfast, Lunch and Dinner from the officers dining hall during their working hours.
5. The Medical officers should make their own arrangements for to and fro transportation for attending work.
6. The period of contract shall be for one year from the date of commencement of the contract, which can be extended at the discretion of the Corporation.
7. The Medical Officers will be paid remuneration of Rs 3,500/- (Rupees Three thousand five hundred only) per shift duty. The remuneration will be the same for all the days, irrespective of it being Saturday, Sunday, Holiday or Hartal day. It will also be the same for all the three shift duties.
8. Payment in respect of the professional services rendered by the Medical Officer will be calculated on a monthly basis based on the total number of Eight hour shift duties done.
9. As per usual practice, TDS at the rate of 10% will be deducted from the amount payable. The same will not be deducted if a copy of the exemption certificate under Sec. 197 of the IT act is produced along with the monthly invoice / bill.
10. The Medical officers shall attend the HSE training provided by Kochi Refinery, before joining duty.
11. The engagement of the Medical officer is purely temporary, on Contract basis and can be terminated by giving one month's notice from either side.
12. The Medical officers will not have any claim for regular appointment in BPCL by virtue of they having worked in BPCL – Kochi Refinery OHC on a contract basis. He / she shall not move to any court / authority for seeking regularization based on the contract engagement.

13. The Medical officer will not be eligible for any of the benefits that are given to the regular employees.
14. The Management reserves the right to call for interview only the suitable candidates. Management may at its discretion, raise / relax the eligibility criteria in-order to restrict the number of candidates or to make available sufficient number of candidates to be called for interview.
15. The duties of the Medical officer shall include:
  - a) General outpatient treatment.
  - b) Basic first aid treatment for emergencies, injuries, etc.
  - c) Escorting patients in the ambulance on a need basis.
  - d) Co-ordination with hospitals where employees or their dependents are admitted.
  - e) Pre-employment and Periodic medical examination of Contract and Permanent employees.
  - f) Any other duties as assigned from time to time, during the duty hours.
16. How to apply: Interested candidates fulfilling the eligibility criteria may submit their application on an A4 size paper (Format furnished below) to **GM(HSE), BPCL Kochi Refinery, Ambalamugal, Ernakulam 682302 on or before 25.05.2023.**

**Note :**

- There is no application fee. All applicants should have a valid/active email ID which should be kept active during this selection process.
- Incomplete applications and applications not fulfilling the eligibility criteria would be “Rejected”.
- **Applications received after 5.00 pm on 25.05.2023 will not be considered.**

- a) MBBS degree certificate and marklist.
- b) House Surgency completion certificate.
- c) Certificate of Registration with “The Travancore-Cochin Council of Modern Medicine.

- f) Aadhar Card.
- g) PAN Card.
- h) Colour Passport size photograph to be pasted at the top right corner of the application.

17. The criteria for selection will be experience and suitability.
