

HON'BLE PRIME MINISTER LAID THE FOUNDATION STONE OF CITY GAS DISTRIBUTION PROJECTS IN WEST BENGAL

It was a momentous occasion for Bharat Petroleum as the Hon'ble Prime Minister, Shri Narendra Modi, laid the foundation stone for BPCL's City Gas Distribution (CGD) project in the Alipurduar and Coochbehar districts of West Bengal.

In his address, the Prime Minister emphasized that this initiative is not just about building infrastructure – it's about empowering over 2.5 lakh households with clean, safe and affordable piped gas. With the construction of CNG stations, green fuel will now be more accessible – saving time, money and the environment. This project, which is expected to generate over 22 lakh man-days of employment and reduce emissions equivalent to planting 50 lakh trees, will propel Eastern India toward a sustainable and energy-secure future.

As a significant step towards expanding the City Gas Distribution (CGD) network in India, Hon'ble Prime Minister Shri Narendra Modi today laid the foundation stone of the CGD project in Alipurduar and Coochbehar districts of West Bengal. The project, with a total cost of over Rs. 1000 Crores, aims to provide Piped Natural Gas (PNG) to over 2.5 Lakh households, 100+ commercial establishments and industries besides providing Compressed Natural Gas (CNG) to vehicular traffic by establishing minimum 19 CNG stations. The project is scheduled to be completed by 30th September 2030. The tap-off point for taking Natural Gas is situated at Ambari and Ghoksadanga tapoff stations of M/s GAIL situated in the Coochbehar District, West Bengal.

The project's key objective is to build a robust gas distribution infrastructure by laying steel pipelines, MDPE pipelines and other equipment for providing PNG connections to households, commercial establishments and industrial customers and CNG to vehicular traffic by establishing CNG stations. Impact of the Project: The project is expected to have a significant impact on the environment, employment, and the community. It aligns with India's net-zero emission goals, promoting natural gas as a cleaner alternative to conventional fuels, reducing greenhouse gas emissions by approximately 27%. During the 25-year project period, there will be a reduction of approximately 98 TMT of greenhouse gas emissions, which is equivalent to planting around 50 lakh trees.

The project is also expected to create over 22 lakh man-days of direct and indirect employment thereby boosting local economic growth. Once fully operational, over 42 lakh population in these districts will enjoy a convenient, reliable, environment-friendly and cost-effective fuel supply. The provision of a robust and efficient City Gas Distribution infrastructure, sets the stage for creating a healthier environment and boosting sustainable development in the districts of Alipurduar and Coochbehar of West Bengal.

WIDENING THE SAFETY ROAD FOR BPCL PP PROJECT

The ceremonial initiation of the widening of R2 Road extending from FACT Main Gate to Kochi Refinery PP Site Entry, for a stretch of 1.7 KM within FACT Area was organised in the gracious presence of Mr. Sankar M, Executive Director (KR), Mr. George Thomas, CGM (HR) and Mr. Satheesh Kumar KP (Projects-PP), and other senior officials of BPCL, along with the Director (Finance & HR) and senior officials of FACT.

The total project cost is Rs 19.5 crores (including taxes). The job has been awarded to M/s Amity Projects and Construction (APCON, with a completion period of 12 months. The project involves widening the existing road to 22 meters, with a 15-meter-wide tarred surface, for a total length of 1.7 km, along with the construction of RCC retaining walls, drainage systems, lighting facilities, and other related infrastructure works.

BPCL officials explained the criticality of the project to the senior officials of FACT, highlighting that it fulfils the contractual obligations under the land agreement. BPCL also sought FACT's wholehearted cooperation to complete the project within the stipulated timeline. FACT officials assured their full support, expressed their happiness, and appreciated BPCL's efforts in finally initiating the long-awaited project despite several challenges.

This road widening is of strategic importance, as it will not only fulfill BPCL's long-pending contractual obligation under the land purchase agreement with FACT but also facilitate the ongoing Polypropylene (PP) project construction by serving as an emergency route and providing a corridor for the movement of PP products and other future developments on BPCL's available land at FACT area.

Students at the SDI, Angamaly also joined the national drive for yoga.








ON WORLD ENVIRONMENT DAY KR PLEDGE FOR SWACHH BHARAT, HARIT BHARAT

"Knowledge sharing is a selfless and powerful tool to help everyone grow," shared Mr. Mahendiran A, Chief General Manager (Operations). He was inaugurating the Knowledge Sharing Session, an internal initiative of the Oil Movement & Storage (OM&S) Department to promote a culture of learning and continuous improvement. This initiative is aimed at creating a collaborative platform where operational experiences and technical learnings could be shared across teams. CGM(Ops) also stressed on the power of such sessions in promoting a safety-focused, learning culture and fostering innovation, accountability, and team alignment. He also urged greater participation to enhance institutional knowledge.

Mr. Vinod PL, General Manager (OM&S) chaired the opening session and explained that focus of the session is mainly on KPIs like (1) Facilitate structured knowledge exchange on real-time operational scenarios; (2) Reinforce a proactive and preventive approach to safety and (3) Capture and institutionalize key learnings from critical events. The session was actively supported by senior leadership of OM&S including Mr. Rajeev K. (DGM), Mr. Vinu Narayan (DGM), Mr. Joseph Rajan (CM), Mr. Rajesh K (CM) and Mr. Ashwin C.P (CM). whose insights added depth and relevance to the discussion. More than 45 employees across OM&S Department participated in the on day one where the first topic of discussion was on the *Overflow Incident of YT113*.

A detailed analysis of the incident was presented by Mr. Abhishek Saini, Asst. Executive (OM&S), highlighting root causes, response, and lessons learned. It served as a learning model to improve operational controls and risk awareness. The key takeaways of the session included clear insight into the YT113 overflow case, importance of real-time monitoring and timely escalation, need for preventive checks and procedural discipline and value of collaborative learning and documenting best practices.

The knowledge sharing session is a testament to the organization's focus on transforming experiences into expertise. With continued commitment to such knowledge-driven initiatives, the OM&S team is paving the way for a more informed, agile, and safety-conscious operational ecosystem







GOK APPROVES BPCL CBG PLANT AT KOZHIKODE

The Kerala government has approved the establishment of a 150-tonne-per-day (TPD) Compressed Biogas (CBG) plant by Bharat Petroleum Corporation Limited (BPCL) in Kozhikode. The project aims to convert organic waste into renewable energy and organic fertiliser, addressing both energy needs and waste disposal challenges.

The plant will be constructed on 7 to 8 acres of land at Njeliyanparambu, leased to BPCL by the Kozhikode Municipal Corporation for a nominal annual fee of ₹1,000 for 25 years, with an option to extend for an additional 10 years. BPCL will invest ₹99 crore in the project, which is expected to process 150 to 180 tonnes of organic waste daily. The biogas produced will be marketed to GAIL, and a fuel station will be established near the plant to supply vehicles operating within the facility. Additionally, 20 to 25 tonnes of organic fertiliser will be generated daily as a by-product. The project is part of BPCL's broader initiative to establish CBG plants in various parts of Kerala, including Thiruvananthapuram and Kochi. In Kochi, a similar 150 TPD CBG plant is nearing completion at Brahmapuram, with operations expected to commence soon.

The establishment of these plants aligns with Kerala's commitment to sustainable development and renewable energy. By converting organic waste into biogas and fertiliser, the projects aim to reduce greenhouse gas emissions, promote waste-to-energy solutions, and support organic farming practices. The success of these initiatives could serve as a model for other regions in India seeking to address waste management and energy challenges. The Kozhikode CBG plant is expected to become operational within 24 months of receiving final government approval. Once operational, it will play a crucial role in enhancing the city's waste management infrastructure and contributing to Kerala's renewable energy goals.

This development underscores the growing importance of public-private partnerships in advancing sustainable urban solutions and highlights the potential of biogas technology in transforming waste into valuable resources.


