Jaish ultra being tracked for a yr killed in J&K

Jammu: Security forces shot dead a Jaish-e-Mohammad (JeM) terrorist Thursday during a gunfight in the rain-soaked Badsinggarh forests in J&K's Udhampur; where three of his aides remain trapped.

Jammu range IG Bhim Sen Tuti said the terrorists are likely part of a group that police

have been tracking in the Jammu region for nearly a year. "The weather is bad in Basinggarh. Once it clears, the situation will become more evident," he said.

Acting on intel inputs about movement of a group of ultras, a joint team of Army and police launched a seek-and-shoot operation in the remote Bihali area early morning.

"As the forces approached the location, the terrorists started shooting. Retaliatory shots were fired," a senior official said. Rain, while slowing troop movement, is helping forces restrict the ultras' range and pin them within the forest.

Tight security preparations are also underway for Amarnath Yatra scheduled from July 3 to Aug 9.

Woman drives 7km on railway tracks near Hyd, halts train traffic

Hyderabad: A 34-year-old woman drove her car nearly seven km on tracks, causing a temporary shutdown of train traffic between Nagulapally and Shankarpally stations, near Hyderabad, Thursday, reports Mahesh Buddi.

The woman, a former IT employee from Lucknow, was intercepted near Shankarpally by railway staff after her vehicle got lodged at a track switching point. Wearing a face mask, she emerged from the vehicle with an iron rod and hurled stones at people who tried to approach her. "Railway staff overpowered her and handed her over to Shankarpally police," said an RPF official.

GRP said the woman was battling severe distress. She had visited Narsingi police station around 6.30am on Thursday, announcing she was going to end life, but left before giving details.
