I, **CS Nrupang B. Dholakia, Designated Partner of the firm**, submit combined report as under:

1. The meeting of Unsecured Creditors through Video Conferencing (VC)/Other Audio-Visual Means (OVAM) was held in compliance with the MCA Circulars and SEBI Circulars without the physical presence of the Unsecured Creditors at a common venue.
2. Compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder relating to Voting (which includes remote e-Voting and the electronic voting during the meeting) to the Unsecured Creditors on the Resolutions proposed in the Notice convening the meeting of the Unsecured Creditors was the responsibility of the management. Our responsibility as a scrutinizer was to ensure that the voting process is conducted in a fair and transparent manner and render a combined scrutinizer's report on the voting to the Chairman on the Resolutions.

7. The facility to vote through electronic voting system as stated under point 6 above had been provided to facilitate voting for those Unsecured Creditors who were present during the Meeting through VC/OAVM and had not cast their votes through Remote e-Voting.
8. On the closure of the e-voting after 15 minutes of conclusion of meeting, the votes cast through e-voting during the meeting and through remote e-voting prior to the date of meeting were unblocked from the website of NSDL i.e. [www.evoting.nsdl.com](http://www.evoting.nsdl.com) on Thursday, 21<sup>st</sup> April, 2022 in the presence of two witnesses who are not in the employment of the Company.
9. I hereby submit a combined scrutinizer's report pursuant to Rule 20(4)(xii) of the Companies (Management and Administration) Rules, 2014 on the Resolutions as set out in the Notice of the aforesaid meeting of Unsecured Creditors based on the scrutiny of remote e-voting and the electronic voting during the meeting and votes cast therein and on the basis of the data downloaded from the electronic voting system of NSDL.
10. Unsecured Creditors who had exercised their vote through Remote e-Voting were not allowed to vote during the meeting in compliance with Rule 20 (4) (xi) of the Companies (Management and Administration) Rules, 2014.
