New facilities commissioned at NHTCCR

new High Capacity Separator Pump and NHT Feed Filter Coalescer skid were commissioned recently in the NHTCCR unit. An implementation as part of TERI recommendation, this transformation promises enhanced energy efficiency and cost savings.

The new separator pump (CRP-001C) has been installed to substitute the existing separator pumps (CRP-001 A&B). The savings envisaged with the operation of the single CRP-01 C pump instead of existing CRP-001 A/B pumps is over Rs. 26 Lakhs per annum. Further more, the CCR charge can be increased up to 140 % of design charge

with single pump operation and spare pump availability.

The NHT feed filter coalescer skid (NH-PK003) has been installed in NHT feed line upstream of feed surge drum (FSD) to protect the NHT reactor from external solid contaminants and moisture that may arise from pipelines or come along with naphtha feed from feed tanks or directly from upstream units. Solid particles accumulatina at catalyst bed top can create high pressure drop across the reactor bed which in turn affects normal operation of the unit. The new skid with standalone cartridge filter and coalescer assembly will remove the fine particles as

fine as >10 microns and traces of water coming along with the feed.

Technology partners M/s Sulzer Pumps India Private Limited supplied the CRP-001C skid and M/s Multitex Filtration Engineers Limited supplied the NHT feed filter coalescer skid. The project was completed by the E&C team consisting of M/s Arun T K (Project Manager), Sreeja Kumaran (Civil), Pralhad Suthar (Instrumentation), Sai Saran (Electrical) under the able guidance of Mr. M P Jayan DGM (E&C) with constant support from M/s Naveen V Nair (PE), Sreeniketh Varier (Manufacturing), Gokuldas KK (Inspection) and Shahed Sheik (Maintenance).

Contractor Equipment Safety Module introduced

With a vision of improving contractor safety, a system for monitoring the statusand health of Contractor's Tools and Tackles like chain slings, chain blocks, web slings, wire rope slings has been introduced in Kochi Refinery.

The system is built upon and added as a module to the already existing GCMS which is being used for the Monitoring of Gas Cylinders in the Refinery. The system enables the Engineer-In-Charge to keep a log of the Contractor's safety equipment

along with their third party Inspection / Certification Date as well as the location of the Equipment.

Further, the system allows the Fire & Safety Department to assign Tag Numbers to the piece of equipment to identify it uniquely and track the same.

Developed in-house by Kochi Refinery IS team members Ms. Manjula Pavithran and Mr. Aiswhariy Baheti, it was launched at the recent PSM Excellence Awards ceremony.

Jingle bells at CR School


