- At the time of execution some services other than that mentioned in the tender could be executed. Payment against these services will be made as per the SOR rates of SOR 2024-27 rates valid as on Nov 2027.
- For non SOR items detailed description of specifications given in the tender document/ price bid against each item. All the equipments supplied should bear one year manufacturer warranty from the date of installation at site.
- If the Bidder is not willing to execute the job, bidder has the option of regret.

BOQ enclosed is indicative. There can be variation upward / downward than above estimated quantities/value. As per site requirement, bidder may be asked to operate other SOR Service items which are not included in the BOQ.

The Corporation does not give any guarantee for minimum amount of the job to be awarded to you. As per the prevailing site conditions / other conditions including local approvals, statutory requirements etc, and job will be executed.

The construction activities will be executed under the supervision of company engineer / Manager Construction. However, the Corporation will have the option to engage third party agency for supervision of the execution.

Above job is to be executed within limited time period of 120 days from the date of LOI or site hand over which ever is later.

Your scope of work also include arranging materials, Labor and Equipment required for the job and their transport/arranging water /power/ royalty payments (if any) /carrying out of lab test etc. to the complete satisfaction of BPCL.
