### **INTRODUCTION:**

M/s Bharat Petroleum Corporation Ltd. ("BPCL") is a Central Public Sector Undertaking of Government of India with a "Maharatna" status. BPCL is an integrated oil company engaged in refining of crude oil and marketing of petroleum products. BPCL operates 3 refineries in India including Mumbai Refinery (12 MMTPA), Kochi Refinery (15.5 MMTPA), and the Bina Refinery (7.8 MMTPA).

BPCL has embarked on Petrochemical Diversification Plan and is in the process of setting up world scale Ethylene Cracker facilities and associated downstream petrochemical units at Bina along with expansion of Bina Refinery, hereinafter referred as "Bina Petchem and Refinery Expansion Project" (BPREP) or the "Project". BPCL intends to increase the refining capacity of Bina Refinery from 7.8 MMTPA to about 11 MMTPA as a part of the Project.

**Gentlemen,**

1. E-bids are requested under Single stage single bid system(Composite bid) from limited bidding for the captioned item in total compliance to technical specifications, scope and terms & conditions of enquiry documents/attachments. Your offer must be complete in all respect and must contain confirmation/compliance to all points of enclosed commercial Agreed Terms & Conditions without any deviations. Please note that issuance of technical and commercial queries is not envisaged and your offer will be evaluated based on input given therein. Hence pre-bid clarifications, if required may be sought from us immediately on receipt of this RFQ.
2. Bidder can download the RFQ from E-Tendering/ E- procurement website <https://eprocure.gov.in/eprocure/app> . Bidders have to submit their bids only through e-tendering website. **No hard copy of the RFQ shall be issued. Bidders to note that any corrigendum/addendum shall be published only on site <https://eprocure.gov.in/eprocure/app>.**
3. Bidders are required to upload the bids (complete in all respects) along with all supporting documents & priced part on the e-tendering website on or before the **BID SUBMISSION DATE & TIME** specified in RFQ. **Physical Bids sent through Fax/Email/Courier/Post will not be accepted.**
4. E-tendering methodology :
  - a) E-tendering *Portal mandates that the bidders are to be registered on the portal. Bidders shall submit their bids through e-tendering (<https://eprocure.gov.in/eprocure/app>) only.*

- b) *All those vendors who have still not registered on the e-tendering Portal are required to register on the same for facilitating uploading of their bids on the e-tendering Portal failing which it will not be possible for them to upload their bids. Pursuant to registration, the vendors are required to inform regarding e-tendering portal registration details.*

*Only e-tendering portal registered vendors can upload their bids on the portal. Therefore, all those bidders who have not complied with the above registration requirements will not be eligible to bid. Request for extension in due date of submission of bids due to non-registration or delayed registration in e-tendering portal shall not be entertained.*

- c) *The bid has to be necessarily submitted on the e-tendering Portal only. Inability of the bidders to upload their bids on account of not completing the registration with e-tendering portal as mentioned above will not be a reason for seeking BDD extension.*
- d) *Vendors who have completed the registration on e-tendering shall only be allowed to submit the bids through e-tendering Portal. Therefore, it is in the interest of the bidders that they register on the e-tendering Portal at the earliest.*

Bidder are advised to download & utilize the available information/documents under these links for activities like Registration in portal, obtaining User ID & Password, uploading & submission of e-bids etc. Bidders are advised in their own interest to carefully go through Instructions for E-tendering and other related document available against various help links so as to ensure that bids are uploaded in E-tendering website well before the closing date and time of bid submission..*

In the event of failure in bidder's connectivity with e-tendering website during the last few hours on account of problem on bidders account, they are likely to miss the deadline for bid submission. Due date extension request due to this reason will not be entertained. In view of the same, bidders are advised to upload their bid in advance.

14. E-bids received online shall be opened on due date and time as specified above. The Bidders who have submitted their Bid will be able to view online the name & status of all the Bidders at their respective windows, after Composite Bid opening by EIL/BPCL.
